### PGA GOLF PROFESSIONALS

A qualified PGA Golf Professional with extensive corporate day is included in all our golf packages. There are a large range of services available for you to choose from allowing you to completely customise your day.

### GOLF CLINICS

Our PGA Golf Professionals offer a wide range of on course services including clinics, tallying of score cards, corporate day coordination, private lessons and course activities. Our team are happy to work with you to design something unique for your guests.

### EQUIPMENT HIRE

Our new fleet of golf carts are one of the ways we ensure your guests receive our best. With a total fleet of 60 Yamaha carts additional carts can be hired if required. We have a selection of buggy and club hire options available. If extra carts are required this can be arranged with four weeks' notice.

### PRIZE HOLES

Prior to your corporate day, our team will discuss the competitions you would like to operate on the day. Popular activities include nearest to pin, approach shots, longest drive or straightest drive. Our staff will place markers on course before your event, and ask that you retrieve them at the end of the day.

### BANNERS ON COURSE

We permit banners on course, installation of two banners is a service we include in all our packages. We can install extra banners for you, if this is a service you require, please liaise with our team in the lead up to your event, banners need to be received by the pro-shop no later than 24 hours before your event. ## TERMS AND CONDITIONS

---

- 1 **Tentative bookings** - Will be held for a period of seven (7) days, after which time the space will be released.
- 2 **Signing the Booking Agreement and forwarding the requested deposit within the designated time** - A corporate or social golf booking is not considered confirmed until we are in receipt of both the signed Booking Agreement and the requested deposit. St Lucia Golf Links therefore reserves the right to cancel the booking and allocate the space to another client, if your deposit and Booking Agreement is not received seven (7) days from verbal confirmation.
- 3 **Final Numbers** - Are required three (3) working days prior to the function for both Golf and Catering regardless of no shows on the day. Should the final number not meet the minimum spend agreed to, the shortfall will be charged as an additional fee as specified in the event Booking Agreement.
- 4 **Cancellation by the client/agent** - The following conditions will apply when a cancellation is made for any reason after a Booking Agreement has been signed and a deposit has been received in writing:
  - 4.1 **For notice of cancellation between 120 & 91 days prior** to the date of the function: The deposit will be rolled over for another event held at Hillstone or hundred acre bar within 12 months.
    - 4.1.1 **For notice of cancellation between 90 & 61 days prior** to the date of the function: A cancellation fee of 25% of the total projected revenue will apply. No refund of the deposit will be made.
    - 4.1.2 **For notice of cancellation between 60 & 31 days prior** to the date of the function: A cancellation fee of 50% of the total projected revenue will apply. No refund of the deposit will be made.
    - 4.1.3 **For notice of cancellation 30 days or less prior** to the date of the function: A cancellation fee of 100% of the total projected revenue will apply. No refund of the deposit will be made.
  - 4.2 **Inclement weather:** Should you cancel your golf day function due to the closure of the course and wet weather, a cancellation fee will not apply if your function is booked in the hundred acre bar. However, should your golf day function be booked in a private function room (Rosewood Room, Library Bar or Grand View Room), your function catering must proceed as normal; otherwise the above cancellation fee will apply.
  - 4.3 **Postponing an event:** Outside the above cancellation criteria, and subject to Management's approval, the venue will consider postponement and re-allocation of deposit monies if the event is re-scheduled with a new and firm date.
  - 4.4 **Outside services:** If any services are booked by the venue on the client's behalf, and subsequently cancelled within 30 days of the function and any fees or charges are incurred by the venue as a result, the client will be responsible for these charges in total.
- 5 **Re-allocation of space** - The venue reserves the right to reallocate a function should the expected numbers decrease below the confirmed minimum.
- 6 **Other functions** - The venue reserves the right to book other functions in the same function room up to one hour before the scheduled function commencement time and one hour after the scheduled function finishing time. Additionally, the venue reserves the right to book a concurrent function in adjoining rooms at any time.
- 7 **Commencement and vacating of rooms** - The organiser agrees to begin the function and vacate the designated function space at the scheduled times agreed upon. If a function extends beyond the agreed finishing time, the venue reserves the right to impose a labour charge for each hour and part hour that the function space is occupied.
- 8 **Room hire** - Is subject to period required, numbers of guests in attendance and overall catering requirements. Our sales staff will discuss room hire along with your requirements.

- 9 **Final function details** - Menus, beverage arrangements, entertaining, audio visual requirements, room set ups, starting and finishing times must be confirmed 14 days prior to the function.
- 10 **Payment** - All function accounts are to be paid in full three (3) days prior to the function unless alternative arrangements have been made with the venue. Any additional charges must be settled within five (5) working days of the function.
- 11 **Terms of payment** - Credit cards: Visa, MasterCard, Bankcard, Amex, Diners; Direct Debit - Hillstone St Lucia Pty Ltd, National Australia Bank BSB 084 004 A/C 50789 3039; personal and bank cheques; or cash, are all accepted forms of payment.
- 12 **Licensing laws** - As part of our duty of care to all patrons, we reserve the right to refuse service to intoxicated guests, those under 18 years of age, or those who are supplying alcohol to minors or intoxicated guests. Due to licensing laws, food and alcohol cannot be brought on to the premises unless prior arrangement has been made.
- 13 **Compliance** - Clients are responsible for the orderly behaviour of their guests and the venue reserves the right to intervene where it deems necessary.
- 14 **Prices** - Will be confirmed in writing along with final function details. Every endeavour is made to maintain prices as printed, but these may be subject to increase due to availability of product. All prices quoted are inclusive of any state or federal government tax or levy.
- 15 **Delivery and collection of goods** - The venue will only accept delivery of goods one (1) working day prior to the function and request that all goods be removed on the completion of the function. Should the goods not be taken on the completion of the function, we reserve the right to forward these goods to you by courier, if they are not collected by 9.00 am the following morning - cash on delivery. In the event that goods are left behind after a function, all due care will be taken however, Hillstone St Lucia will not be held responsible or liable for these goods. All goods are to be delivered to the venue between 10.00 am and 4.00 pm Monday to Friday except where prior arrangement has been made.
- 16 **Personal effects** - Hillstone St Lucia prides itself on taking care with its guests' and their guests' belongings. However, we cannot accept responsibility for damage or loss of items left at Hillstone St Lucia, before, during or after an event.
- 17 **Displays and signage** - No items are to be pinned, screwed, glued or otherwise attached to the walls of any area of the venues unless otherwise approved by the venue.
- 18 **Venue & Golf Cart Damages** - Clients are financially liable for any malicious damage sustained to the venue or golf carts caused by the actions of their guests, their outside contractors or any other persons attending the function.
- 19 **Insurance** - It is the client's responsibility to take out insurance for all items belonging to them or their guests for the period those items are in the venue.
- 20 **Fire, life and safety** - The venue retains the right to adjust any set up to ensure fire, life and any other safety codes are not breached.
- 21 **Car Parking** - Ample free car parking is available; however, depending on your guest numbers, car parking attendants may be required at an additional charge.
- 22 **Sponsorships** - All sponsorships are subject to approval in the absolute discretion of Hillstone St Lucia. In line with the licensing laws and distribution agreements, there are very strict guidelines associated with food and beverage sponsorship.
- 23 **No Smoking** - In accordance with the State Government's anti-tobacco laws from 1<sup>st</sup> July 2006, smoking is not permitted indoors and outdoors where food and beverages can be provided, including the terrace/verandah areas and the golf course itself. Should guests wish to smoke, they must move to the signed smoking area, which is outside of the licensed premises and where no food and beverages are served.
